LONDON BASED PART-TIME and DISTANCE LEARNING Montessori Early Childhood Diploma Courses

Registration Fee (part-time students only)

On registration all part-time students pay a non-refundable fee of £100 and understand that upon acceptance on the course students are required to pay a £500 deposit which is refundable against the last instalment of fees.

IMPORTANT: Prospective students are advised to pay particular attention to the terms and conditions on the registration form before forwarding their registration form and fee. If necessary they should discuss their requirements with the admissions officer.

Methods of Payment

PART-TIME COURSE

You can save on your part-time course fees if you pay for your course in full before the start of your study. Alternatively you can pay in three instalments as outlined below.

DISTANCE LEARNING COURSE

Distance learning fees must be paid on application. The fees include two options: Payment for course work components only, or a discounted fee when paying for both the coursework components and the workshop on registration for the course, applicable for London Workshops only. Students with a UK bank account may opt to pay by 4 monthly instalments through Holmwoods Termtime Credit as outlined below.

Instalment Payment Dates for Part-time Courses

Following an approved registration, tuition fees for the full course become payable as follows:

The terms and conditions of your commitment to pay the tuition fees are stated on the registration form. Acceptance on the part-time course is conditional upon your agreement to these terms and conditions. Fees are due prior to the above payment dates and the college reserves the right to administer a surcharge if the student fails to observe these conditions.

Monthly Payment Plan (Available through Holmwoods Termtime Credit)

The termly instalment fee for **Part-time courses** may be paid by 3 monthly Direct Debit payments.

Distance Learning Course Fee (coursework components only) may be paid by 4 monthly Direct Debit payments. All payments will be subject to a 3% service charge. Details may be obtained from the Accounts Department.
